



## IISL WORKSHOPS PUBLICATIONS GUIDELINES

The IISL Workshops provide an excellent format for bringing together international researchers for intensive discussions. They also offer a very good basis for developing high quality publications, which the Institute is happy to support. These Guidelines explain our publication arrangements.

The IISL offers two modes of publication of papers resulting from workshops: digital or printed. It is a condition of hosting a workshop that the IISL is entitled to first refusal for either of these forms of publication. Track record of publication from previous workshops is a relevant criterion for workshop selection.

A decision needs to be made before the conclusion of the workshop regarding the preferred form of publication. Whichever form of publication is selected, one or more editors of the collection of papers should be chosen, who would normally be the workshop organisers. Editors should normally include a native speaker of the language(s) in which the papers are written. Editors are responsible for communicating with the IISL about the form of publication chosen, timing and selection of reviewers. Authors are responsible for revising their papers, ensuring that they are of high publishable standard, and are provided on time.

### OÑATI SOCIO-LEGAL SERIES

The *Oñati Socio-Legal Series* is a peer-reviewed, international online publication, with articles covering any aspects of socio-legal studies and sociology of law. It is available on the IISL website, and distributed through the Social Science Research Network (SSRN), indexed in Dialnet, Directory of Open Access Journals, Google Scholars, ISOC and Redib, which ensures wide dissemination. It is also included in ERIH Plus (European Reference Index for the Humanities and the Social Sciences).

A collection of papers from a workshop, if approved for publication in the OSLS, is presented as a separate issue of the Series, with its own title. The editor(s) of each collection of workshop papers will be the issue editor(s). Papers are peer-reviewed by two referees: one nominated by the Issue Editor; and the other by the Scientific Director. Papers may be in any language, usually English or Spanish, and would usually be up to 15,000 words in length.

We do not accept papers that have been previously published, or have been simultaneously submitted to another publisher. However, authors are free to republish the work or revised versions. Authors retain copyright, and the IISL only retains a non-exclusive right to communicate the paper to the public, normally on the terms of a Creative Commons Attribution Non-Commercial No-Derivatives licence. The IISL also asks that any later publication should include the normal acknowledgement that the paper was given at an Oñati Workshop, with a link to the *Oñati Socio-Legal Series*.

A paper cannot be both published online and included in a book proposal. However, it is possible for some papers to be included in a book proposal with others from the same workshop submitted to the *Oñati Socio-Legal Series* provided they are of publishable quality. Single papers can also be submitted for publication in the Series.

## BOOK PROPOSALS

Workshop organisers are also welcome to proposals an edited collection to be published in either of the two book series: *Oñati International Series in Law in Society* published by Hart-Bloomsbury Publishing, or *Colección Oñati: Derecho y Sociedad* published by Dykinson. Book proposals should normally be no longer than 300 pages (120,000 words including footnotes and bibliography).

Authors will not be paid royalties on the books published in either of these series.

A proposal should include:

- (i) a draft introduction or key chapter, based perhaps on the original workshop proposal, or on a thematic paper presented at the workshop. It should be a substantial statement and exploration of the themes of the book, indicating the contributions of the various chapters, rather than just a series of summaries of the papers;
- (ii) a Table of Contents listing and grouping the chapters, with a summary or abstract of each chapter, its word length, and a realistic estimate for completion of the final version; sample chapters could be included if they are in a fairly final version;
- (iii) an explanatory statement outlining why the collection is especially suitable for publication as a book. This should include a discussion of the type of reader at which the book is aimed, the likely markets, and the main competitors, identifying the strengths and possible weaknesses of the book in relation to what is already available on the topic.

A book usually does not appear until 2-3 years or more after the date of the workshop, and so it must have a long-term interest and potential for impact. Papers should not only be good in themselves, but should have a clear coherence and focus as a collection, with an inter-weaving of the ideas and debate between the various papers.

Proposals should be submitted by the **10<sup>th</sup> September** of the year of the workshop to Leire Kortabarria ([leire@iisj.es](mailto:leire@iisj.es)), our Publications Officer, who will send them on to the Publisher for evaluation. The Publisher's decision will be based on both the commercial viability for publication as a book, as well as the quality of the proposal. The Publisher will also take advice from the General Editors of the relevant series: for the Hart series David Nelken and Rosemary Hunter, and for the Dykinson series Joxerramón Bengoetxea and Carlos Lista. If a book proposal is not accepted by the Publisher, it may be published in the *Oñati Socio-Legal Series*, or submitted to other publishers.

The publisher will deal directly with the editors and authors of proposed books. This includes, once a proposal is accepted, timetable for submission of the final manuscript, and refereeing.

## **ACKNOWLEDGEMENTS**

Whatever the form of publication, the Institute requests that papers should be accompanied by the usual acknowledgement that they were given at an Oñati workshop.
