Cindy L Baldassi is a PhD student at the University of British Columbia, Faculty of Law, working mainly on the definition of family, including immigration and the legal consequences of genetic ties. After finishing her LLB at Osgoode Hall, she clerked at the Federal Court of Canada, and then completed an LLM at UBC, where her thesis focused on the question of treating embryo donations as if they were adoptions.

Anne Barlow is Professor of Family Law and Policy at the University of Exeter. The main focus of her sociolegal research has been on cohabitation law and comparative family law, although she also has an interest in housing, property and welfare law. She has led and co-directed a number of funded interdisciplinary empirical projects in these fields. Her recent publications include *Community of Property—A Regime for England and Wales?* (with Elizabeth Cooke and Therese Callus) (Bristol, Policy Press, 2006), and *Cohabitation, Marriage and the Law: Social Change and Legal Reform in 21st Century Britain* (with Simon Duncan, Grace James and Alison Park) (Oxford, Hart Publishing, 2005).

Anne Bottomley is a faculty member of Kent Law School, University of Canterbury. She has published extensively in the areas of feminist theory, and property and trusts; recently editing (with Hilary Lim) *Feminist Perspectives on Land Law*, to which she contributed a chapter entitled 'A Trip to the Mall: Rethinking the Public/Private Divide'. She is now working on two projects, one focused on community aspects to land holding (a portion of which is represented in this collection), and completing a book (with Nathan Moore) entitled *Cities, Cinema, Control*.

Susan B Boyd is Professor of Law and holds the Chair in Feminist Legal Studies at the University of British Columbia in Canada. She has published extensively on family law reform, the privatisation of economic responsibilities, parenthood law, and feminist legal theory. She recently co-edited *Reaction and Resistance: Feminism, Law, and Social Change* (2007), *Poverty: Rights, Social Citizenship, and Legal Activism* (2007) and *Law and Families* (2006). Her book *Child Custody, Law, and Women's Work* was published in

2003. She held a British Academy Visiting Professorship in 2005. She is Director of the UBC Centre for Feminist Legal Studies.

Alison Diduck researches and teaches in the Faculty of Laws at University College London. Her current research interest in family law and feminist legal theory is in the public and private regulation of intimacies and other personal relationships. Her publications include *Law's Families* (LexisNexis, 2003), *Family Law, Gender and the State* (with Felicity Kaganas) (Hart Publishing, 2006) and *Feminist Perspectives on Family Law* (with Katherine O'Donovan) (Routledge-Cavendish, 2006).

Susan Scott Hunt, Attorney (US), Solicitor (UK), is a Principal Lecturer in Law at Middlesex University in north London. She teaches Equity & Trusts and Contract Law and is the programme leader for the CPE/GDL. Her research interests include Equity & Trusts and feminist legal scholarship. Nan Seuffert teaches at the University of Waikato, School of Law, in Hamilton, New Zealand. She publishes in critical legal and race and gender studies as well as in securities regulation.
