## Nor gara

Oñatiko Lege Soziologiako Nazioarteko Erakundea (LSNE) orientazio akademikoko irabazi-asmorik gabeko erakundea da, erregimen publikoko fundazio pribatu gisa eratua. Estatutuen arabera, LSNE zuzenbidearen soziologiako nazioarteko ikerketa zientifiko eta teknikoan aritzen da, eta nagusiki Euskadin garatzen ditu bere eginkizunak.

LSNE 1988an sortu zuten Eusko Jaurlaritzako eta Lege Soziologiako Ikerketa Batzordeko (RCSL) ordezkariak, Soziologiako Nazioarteko Elkartearen barruan. Bere egoitza, zerbitzu nagusiak eta lege-soziologian espezializatutako liburutegia Oñatiko Unibertsitate Zaharrean daude. Gune horiek Gipuzkoako Foru Aldundiak lagatakoak dira. Gainera, LSNEk Antia egoitzan ostatu hartzeko aukera ematen die erabiltzaileei, Santa Marina plazako 5. zenbakian, Oñatiko erdigunean. XVIII. mendeko eraikin historikoa da, Oñatiko Udalarena.

LSNE estu lotuta dago Euskal Herriko beste erakunde publiko batzuekin, tartean Euskal Herriko Unibertsitatearekin (UPV/EHU) eta Ikerbasque Zientziarako Euskal Fundazioarekin. LSNEko zientzia-zuzendaria bi erakundeetako kidea da. Hala, LSNEk Lege Soziologiako Nazioarteko Master Programa bat antolatzen du UPV/EHUrentzat.

## Xedea

Bere Estatutuen arabera, LSNEren helburu nagusia zuzenbidearen soziologiako ikerketan aurrera egitea da, eztabaida akademikoen, analisiaren eta alderaketaren bidez eremu guztietan izandako garapenei aktiboki jarraituz. Horretarako, LSNEk harremanak ditu Euskal Herriko Unibertsitatearekin eta beste euskal erakunde batzuekin, tokiko testuinguruan integratzen laguntzeko eta euskal herriarekin, bertako gizartearekin eta kulturarekin harremana izateko.

## Ikuspegia

LSNEk eredu izan nahi du nazioarteko lege-soziologian. Estatutuen arabera, horrek, batez ere, ikerketa zientifikorako benetako espiritua sortzea ekarriko luke, gaitasun akademikoen ezein helburuk oztopatuko ez lukeena. Aitzitik, motibazio nagusia izango litzateke elkarrengandik ikastea, kritika konstruktiboak egitea eta esperientziak, pertzepzioak eta ezagutzak partekatzea.

## Children's rights & the right to a healthy environment – intersections & opportunities

Api. 11 - 12 2024

MINTEGIAREN HIZKUNTZA: INGELESA

### LABURPENA

This workshop aims to bring together expert scholars working in two areas of human rights law – those studying environmental human rights, and those working in children's rights. The workshop will be a unique opportunity for these scholars to come together and think through synergies, theories and potential conflicts across and between these two fields. It is an exciting time in both disciplines. In 2022 the General Assembly adopted a resolution recognizing the right to a clean, healthy and sustainable environment. The UN committee on the rights of the child is currently in the process of drafting a general comment on the rights of children to a healthy environment. Yet there has been limited research on the intersection of children's rights and environmental rights. This workshop fills this gap, hosting papers and discussions on this topic. We will engage in critical discussions on what exactly the right to a healthy environment means, and potential consequences of developments in the area for children rights; particularly in relation to the UN convention on the rights of the child.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The climate crisis is of course a global phenomenon and the Basque country is affected, as are all other countries. The Basque country is also forward thinking when it comes to environmental matters. One of the organizers of this proposed work shop (Dr Daly) was an author of a report of the European network of ombudspersons for children (ENOC) on children and climate justice, surveying practice in 40 countries across Europe, and therefore has a good knowledge of the topic of environmental rights in the region. The School Agenda 21 in the Basque Country has been recognised by UNESCO as one of the 25 best practices in education for sustainability worldwide. It is based on the participation of the community, developing knowledge, skills, attitudes, motivation and commitment to take part in solving environmental problems. As well as this, the young person's consultation for this ENOC report occurred in the Basque country. Dr Daly has links with NGO Save the Children and young people in the Basque country who worked on the climate justice report, and is working to involve them in the workshop.

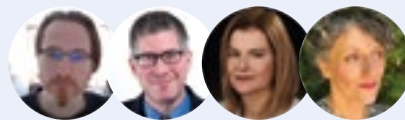
## Situating the 'Global East' in Southernizing & Decolonizing Movements in Socio-Legal Studies

### LABURPENA

Southernizing and decolonizing movements in social science aim at giving greater voice to those from colonized regions. We expand this aim to East-Central Europe & Eurasia (ECEE), the countries of which have so far been left out of postcolonial analyses in criminology and socio-legal scholarship in the English language. To meet this goal, we will host a two-day workshop. This workshop will achieve the following three goals: firstly, we will seek to understand and thereby correct the erasure of ECEE from southernizing approaches to socio-legal studies. Secondly, our workshop will help to build and support an 'eastern' southernizing network in socio-legal studies and criminology, expanding and promoting criminological knowledge production from the region. Thirdly, we intend to develop a conceptual language for thinking about coloniality and knowledge production in socio-legal studies of the 'Global East'.

### LABURPENA

Community-engaged or participatory action research (PAR) is an established research framework that employs principles of co-ownership and co-production of knowledge between the community and researcher, works to identify problems and solutions at the community level, values community knowledge, and creates collaborative partnerships, with a commitment to community benefits. This Workshop will bring together international law and society scholars to critically interrogate this approach as a methodology of sociolegal work. Despite the origins of law and society practice being focused on impact and change (e.g. community legal clinics and cause lawyering), and while much law and society work engages with communities (e.g. migrant workers, post-conflict societies, LGBTQi folks, sex workers), how we understand community-engaged research as a methodology of sociolegal work has been less well documented and reflected on. This international Workshop will bring together researchers from Australia, Indonesia, Nigeria, Puerto Rico, Peru, Uganda and Canada to do just that.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The Basque Country has a strong tradition of social justice activism and feminist mobilization. This workshop engages questions of community-university collaborations and meaningful community participation in funded research projects. We see these broad questions as relevant to the Basque Country and, in particular, to the evaluation of recent law reform on gender violence. Most of these participants in the proposed workshop have been working on questions of prevention of gender violence and survivor-centered approaches to law reform and reparations across diverse settings. We hope this will spark reflections on “the involvement of the victims in social protection awareness training, family involvement, improving the role of the police” etc.

## Digital Intermediaries in Domestic & Care Work Sector

### LABURPENA

In recent years, the emergence of digital platforms in various sectors has challenged traditional ways of organizing and regulating work. Digital platforms have grown up in the interstices of regulatory frameworks. As a result, academic debates have focused on regulation to ensure social protection for platform workers. Most of the existing empirical research has focused on the delivery and transport sectors. Only recently has a field of research on digital intermediaries in domestic and care work begun to take shape. With the aim of preparing the first book on this topic, the workshop aims to bring together scholars from different countries to reflect on the impact of digital intermediation in the domestic and care sector, as well as the mechanisms to guarantee the labor and social rights of the (mostly female) workers.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The originality of the proposed topic makes the workshop highly relevant both for the Basque Country and for the European Union as a whole and other countries outside the EU. The intervention of digital intermediaries in the domestic work and care sector is becoming more and more relevant every day, so it is crucial to produce knowledge about this new phenomenon that tends to disrupt the social and economic dynamics of this particular sector of the economy.

## Law and Political Economy in Latin America: Problems & Perspectives for a Transnational Agenda

### LABURPENA

In recent years, several initiatives have sought to place the complex relationship between law and political economy at the center of their analysis. This renewed interest has brought with it new theoretical and methodological developments, as well as a rich research agenda aimed at exploring the mutual constitution of socio-political environments and legal institutions. Despite these advances, most initiatives in this field have remained focused on the realities of countries in the Global North, neglecting the potential yields that could arise from developments in trajectories from other regions of the planet. In this context, this workshop seeks to fill this gap by bringing together researchers from around the world who have focused their work on the relationship between law and political economy as a framework for the study of socio-legal transformations and conflicts around the economic order in Latin America. On this basis, the event seeks to create a space for discussion on the development of this field of study in the Latin American context and its potential thematic, theoretical, and methodological yields that it could have for the reflection of socio-legal research.

## Changes in Society, Welfare, Penalty, Law, and Justice: Implications for the Future of Criminological & Socio-legal Theorising

### LABURPENA

Since the earliest theories of crime developed by psychologists, sociologists of the law and socio-legal scholars, the causes of crime have been focussed on individual-level family and community-level factors. However, recent theorising and empirical research has started to explore influences on offending and criminalization which are found at the state, regional or national-levels. Whilst national-level data (e.g. economic conditions, levels of consumption, divorce rates and justice system resources) are often cited in explanations of national crime rates over time, there has been relatively little attention given to national experiences as explanations of individual-level offending by socio-legal, criminological, sociological or psychological researchers. This has hampered theoretical development. This workshop will assess the extent to which national/regional-level data can be incorporated into theories of offending and criminal justice, and the impact of this on future criminological theories. The workshop will reinvigorate sociological and socio-legal theorising on the causes of crime.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

A central aspect of the workshop corresponds to the question of how contemporary research in law and political economy has been developing around the economic order in Latin America. As this is a highly interdisciplinary field, we consider that its development may raise relevant questions and reflections for socio-legal research and sociology of law, two fields with a wide development in the Basque Country. In this sense, we believe it is relevant to take a first step in the characterization of this field by focusing on the Latin American context, since it is a scarcely explored area but with a rich tradition in the development of approaches that have challenged the traditional and formalistic approaches to the study of the legal phenomenon. In addition, we believe that the organization of this event represents an important step forward in the current state of development of the generation of knowledge on this issue in the region, as well as in the articulation of a joint vision of its main manifestations and scope. Given the topics and approaches that have been developed in this field, we consider that the relevance of the event lies fundamentally in its potential contribution to legal sociology and/or socio-legal studies.

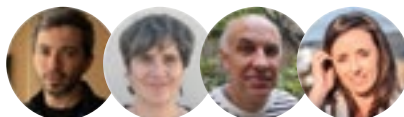
This workshop proposal is relevant to the Basque Country because it will gather many experts on projects developed in different countries around the world (such as the USA, Australia, Spain, Sweden, Switzerland, Scotland, England, Northern Ireland and representatives from Germany) who will discuss issues that are related to Basque policies and programs. These discussions will relate to the local, provincial and autonomous levels of activity in the Basque in the fields of safety, policing, justice, prison and crime prevention, including restorative justice policies (the Basque Government has developed its own police and crime prevention model for different offences and is a member of the European Forum for Restorative Justice and other international organisations relevant for adults' and youth justice). Moreover, colleagues from different Basque Universities and research centres frequently study these topics in line with the proposed themes of this proposal and the general topic of sociology of criminal law, legal professions and social control.

### LABURPENEA

Ante ello, el workshop persigue la construcción de un espacio común para la convergencia y la construcción de un conocimiento más integral y colectivo, así como también para la búsqueda de alternativas a los regímenes de excepcionalidad en las fronteras.

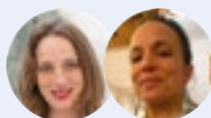
### GAIAREN GARRANTZIA EUSKADIRENTZAT

Entre los espacios fronterizos bajo estudio, el workshop presta especial atención a la llamada "Frontera Bidasoa" en el País Vasco, ubicada entre las ciudades de Irún y Hendaya. A pesar de tratarse de una frontera interior Schengen, en los últimos años la vigilancia y el control se han incrementado en esta zona. Diferentes motivos relacionados al mantenimiento de la seguridad han hecho germinar una nueva zona donde impera la excepcionalidad y los derechos quedan suspendidos. La condición de frontera interior Schengen provoca que tales prácticas no tengan una repercusión semejante a la que se genera en las fronteras exteriores. El workshop busca contribuir a la reversión de este panorama, a través de la identificación de alternativas de trabajo desde la academia en conjunto con las organizaciones y movimientos sociales.

### LABURPENEA

Lower national courts are increasingly asked to perform a transnational role and they are directly involved in major geopolitical issues. Their role as international players, however, has been largely overlooked and such analysis is, usually, limited to the realm of constitutional/supreme courts. Fulfilling this research gap, the workshop builds on extended localized research, aiming to track interconnections within the transnational legal order produced by, and reflected on, national lower courts. We will reflect on the roles played by local courts as global actors through their geographical regions as to foster comparative and contextualized discussions, by adopting a multi-disciplinary approach. The workshop suggests developing a conceptual and methodological framework to study lower courts based on four dimensions: (1) The dynamics of legal doctrines (2) The role of human actors; (3) The impact of the institution (4) Geo/political interdependence and geographical interconnections.

### LABURPENA

El objetivo fundamental del workshop es poner en común y contrastar análisis y opiniones sobre diferentes aspectos del -hoy por hoy- último texto legislativo español de Derecho antidiscriminatorio, como es la ley 15/2022 integral de igualdad de trato y no discriminación. Para ello está organizando varias jornadas (hasta el momento dos) con el objetivo de identificar retos, oportunidades, potencialidades y limitaciones en torno al contenido posible y deseable de esa futura Ley. Dos de las organizadoras del workshop están siendo invitadas a esas Jornadas, entre otras cosas por dirigir la Clínica Jurídica por la Justicia Social de la UPV/EHU, cuyo ámbito de actuación se inscribe en el Derecho antidiscriminatorio. ## Opening the Black Box of International Criminal Investigations: Challenges of Culture and Practice

### LABURPENA

Over the past decades, international criminal justice has exponentially grown. New institutions were established to address gross human rights violations and atrocity crimes across the globe. These institutions conduct investigations in devastated and conflict-ridden communities with traumatised victims, while investigators are often working in a different cultural context. Surprisingly little is known about the conduct of international criminal investigations and the challenges of culture. This workshop will open this 'Black Box' of (international) criminal investigations. It brings together a multidisciplinary group of researchers with practitioners of international criminal investigations to share knowledge, experiences and expertise. Practises and challenges of international investigations will be discussed, and problems of intercultural communication will be examined. The workshop aims at developing good practice for investigative interviewing in culturally challenging contexts and broadly for international criminal investigations.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

Shedding light on and improving investigations of crimes is important for domestic as well as international criminal justice systems. This includes relevant practices by professionals, and in particular interviewing victim-witnesses, who are often traumatised by the events. In the domestic as well as in the international realm cultural differences between legal professionals, who conduct investigations, and victims, witnesses and offenders pose additional challenges. Such investigations are particularly challenging when dealing with international crimes like e.g. war crimes, but also terrorism domestically. The topic of the workshop, and the group of international experts and researchers, which it brings to the Basque country has attracted the interest of a number of colleagues. Professors Gemma Varona Martinez, Jose Luis de la Cuesta, and Miren Odriozola have all expressed their interest in the workshop and offered routes of dissemination to colleagues and practitioners in the Basque country. Xabier Agirre from the Basque country will contribute his experiences of international criminal investigations.



## A colloquium at the intersection of law, society, and cognition: integrating sociological and philosophical paradigms with the cognitive sciences

### LABURPENA

The intersection between socio-legal studies, philosophy/legal realism, and cognitive science can enhance our understanding of the legal system's interactions with society and individuals. Legal reasoning and decision-making are areas of inquiry that benefit from cognitive science research revealing that emotions, biases, and heuristics can lead to errors in judgment and decision-making.

The structure of the workshop is organized around 4 main streams: Law, society and cognition; Legal realism and cognition; Legal philosophy, language and cognition; Law, neuroscience and cognition.

Potential topics include, but are not limited to: The cognitive biases and heuristics that influence legal decision-making; The ways in which social and cultural factors shape legal systems; The impact of legal and social policies on human cognition and behavior; The impact of neuroscience in the context of criminal and civil justice; The relationship between the social sciences and the cognitive sciences.

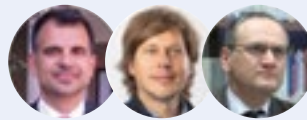
## The Notariat Across Borders

### LABURPENA

Internationally, the notarial profession is highly fragmented, despite shared historical origins and many functional commonalities. Depending on the jurisdiction in which notaries practice their trade, however, there are significant differences in the legal work notaries perform. The impact of notarial work on social structures and economic conditions in societies is considerable but has historically been relatively unexamined. This workshop will create a significant contribution to the (currently sparse) body of knowledge about the notariat, forging the international connections required for a thorough and productive analysis. The specific project associated with the workshop is a comparative and interdisciplinary examination and analysis of a profession that has existed for centuries, but remains little known.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The Basque Country is home to some research and study centers relevant to the study of cognitive science, such as the Basque Center on Cognition, Brain and Language, or the UPV Institute for Logic, Cognition, Language and Information, whose director (Prof. Maria De Ponte), has been invited to the workshop. The relationship between law and cognition is particularly relevant for the Basque countries at least in three respects:

**Language:** The Basque language is unique and complex, and the cognitive sciences offer insight into how humans process and learn the language. Considering that the law is also a semiotic system, these two levels of complexity may interact in meaningful ways. **Culture:** The Basque culture is rich and diverse, and the cognitive sciences can help us understand how culture shapes cognition and behavior, also with regard to the law. **Technology:** The cognitive sciences have many applications in technology, including artificial intelligence, robotics, and human-computer interaction. The Basque Country is home to many tech companies, and legal-cognitive science research could help these companies develop better products and services for lawyers.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The legal system within the Basque Country is based on Roman law, and the notary profession within the Basque country follows the civil law model. Including the role and work of Basque notaries within the comparative analysis carried out through the project (including an economic analysis) is highly relevant at this time and reflective of legal and social change in the territory. The Basque country notary is on the front line in applying the new law on inheritance, for example, which has existed for a year in Biscay, Alaba and Guipuscoa, but not elsewhere in Spain, and which allows the disinheritance of one's children, in order to protect one's spouse and not to scatter one's assets. In addition to the application of this and other specific laws, the project will include an examination of the legal and social frameworks in which notaries operate more broadly, including language diversity (Basque, Spanish and French) and training. We are currently looking for one (or more) participants from the Basque Country (researcher and practitioner).

## The Socio-Politics of Legal Design & their Epistemic Consequences

### LABURPENA

The workshop aims to bring together researchers who are working in the field of legal design to interrogate the emergence of vocabularies of the field and unpack their epistemic consequences. From its roots in industrial production, the introduction of design practices in the legal field has tended to align with dominant logics of the free market, efficiency, and management. Leveraging on a rich plurality of research and practices, disciplines, and experiences, we will interrogate these concepts in light of the lessons and experiences from socio-legal studies. We will not only listen and discuss, but also act on the most pressing epistemic challenges, envisioning counter-vocabularies which will serve as alternative forms of being and creating knowledge in legal design research and practice. The increasing application of legal design in reforms of the justice and legal systems/services, makes addressing the epistemological consequences of its application an urgent endeavour.

## Corporate involvement in Atrocity Crimes, Gross Human Rights Violations, and Ecocide: Patterns of involvement, strategies for prevention and accountability

### LABURPENA

Atrocity crimes are gross human rights violations and criminalized in international criminal law. Business actors and transnational corporations have been involved in such crimes, side by side with states and non-state actors. While conflicts and war often are conducive, corporations have been perpetrators in peace times, in tandem with repressive regimes, involved in ecocide and environmental crimes. Internationally a range of soft law instruments have been developed to prevent such crimes and make corporations accountable. The workshop aims to bring together academics and experts from fields including business, human rights, and crime prevention, to focus on identifying patterns of such crimes and designing effective mechanisms to prevent corporate involvement in atrocity crimes, gross human rights violations, and ecocide.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

The workshop will bring together different perspectives on law, sociology of law, and design to discuss the epistemological implications, as well as to find common grounds to propose alternatives to the current developments of legal design. In this regard, the workshop is also relevant for the developments of the legal and justice systems in the Basque country, and the epistemological implications in the recent history and present of the country. Moreover, during 2022, Bilbao hosted the biggest design conference (DRS), including a track on legal design. In the context of that conference, the authorities of the Basque country and the city of Bilbao emphasized the decisive role that design as a discipline will play in the development of the country, both in the private and public sector.

Against this background, we will invite researchers and practitioners working with communities in the Basque Country, to learn from their experiences and struggles in relation to social justice. We will place special emphasis on knowledge generated in social movements that can contribute counter-vocabularies to the mainstream legal design. Moreover, as convenors, we will offer a master class for members of the IISL community in which we will introduce main topics of legal design and bridge it to socio-legal studies.

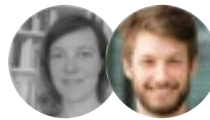

In this project, leading academics from Basque country Juan José Álvarez Rubio and Katerina Yiannibas (both invited) played a crucial role. ### LABURPENEA

Public ombuds institutions, often placed at the core of the administrative justice system, do not only resolve citizens' complaints about public administration but also function as human rights mechanisms in many countries. Despite their important role in access to justice, there is still a lack of research in many aspects – the proposed workshop aims at filling this gap by including critical scholarship (feminist and post-colonial) as well as the impact of current global events and developments (migration, war, pandemic) on ombuds work. This workshop builds on an existing network and two previous workshops at IISJ but, due to a focus on empirical research and a broad, comparative approach to ombuds institutions, takes the current academic debates a step further. Selected contributions of the workshop will result in a (third) anthology to make a lasting impact of this necessary exchange among scholars and practitioners.

### GAIAREN GARRANTZIA EUSKADIRENTZAT

We have invited the acting Ararteko/ombudsman of the Basque Country, Manuel Lezertua, who will present results of the user survey, which is regularly conducted by the Basque ombuds, as well as sociological data, including a typology of claimants and claim format. Moreover, fitting to the focus of this workshop, he will report about complaints and inquiries related to the COVID-19 pandemic as well as on the relation between citizens (their rights) and the electronic public administration, including the problems encountered in the developing digital transformation and possible solutions. In addition, Manuel Lezertua will talk about the European and international dimension of the activities of Ararteko.

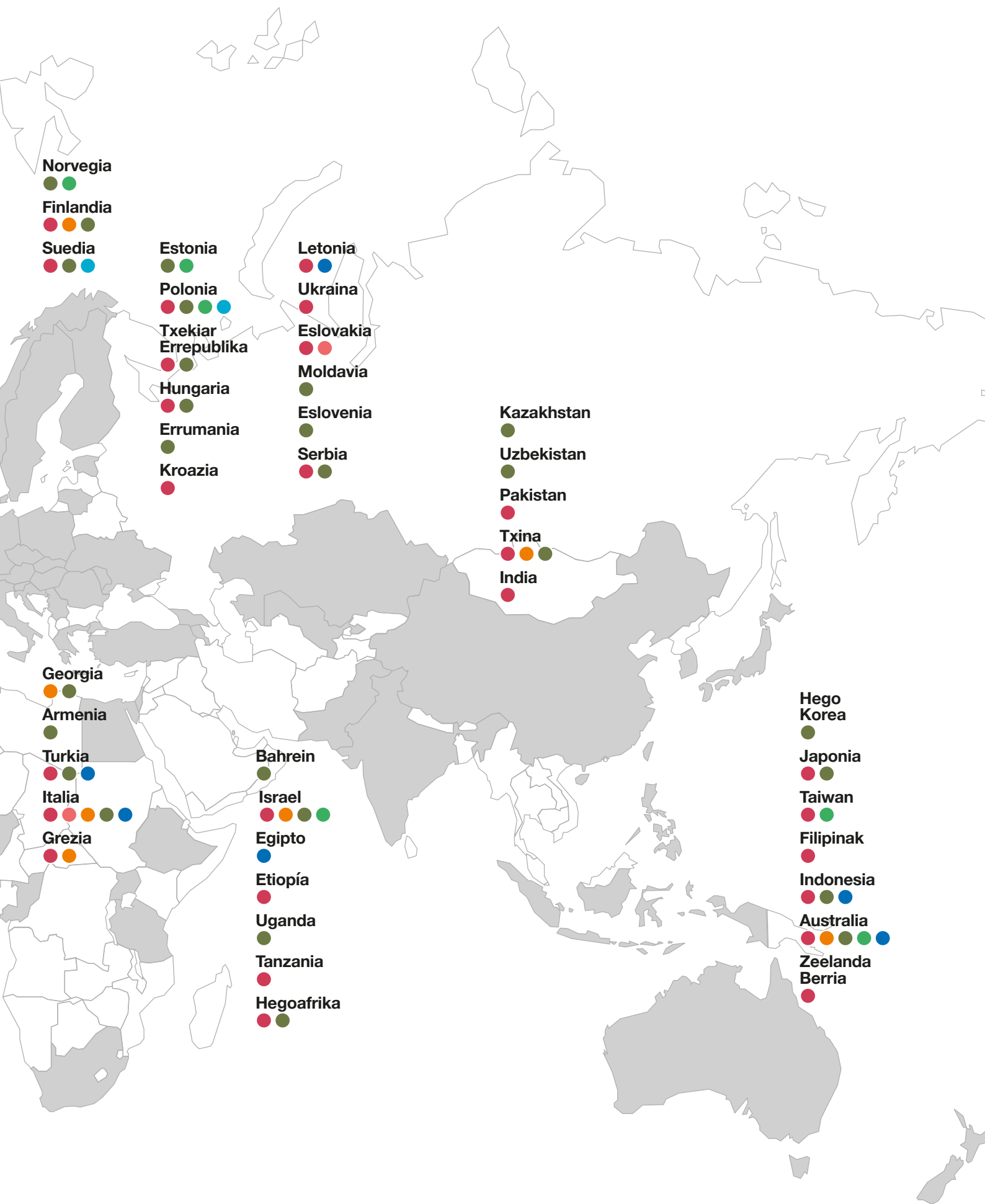
