Justification

The conference entitled **Social dialogue and concertation of labour policies as instruments of change** aims to give continuity to the the Congress The Future of the Work We Want: A Global Debate, which, on the occasion of the Centenary of the International Labour Organisation (ILO) and sponsored by the Department of Labour and Employment of the Basque Government, was held in April 2019 at the International Institute for the Sociology of Law in Oñati. At that meeting the Basque Ministry of Labour and Employment presented the **Oñati Declaration**, a document that would be officially registered shortly afterwards at the ILO headquarters in Geneva, as the contribution of the Autonomous Community of the Basque Country (ACBC) to this important commemoration. That Declaration expressed the institutional commitment of the Basque Government to a model respectful of international labour law and the different social dimensions of labour law. As a result, and for the purposes of assessing and submitting for deliberation the progress made in this field in spite of the adverse context of the pandemic, the Conference (Basque SMEs in the face of the transformations in the world of work quality of work in a context of reforms) was held in 2022, organised by the Oñati IISL and the UPV/EHU in collaboration with the University of Deusto.

On this occasion, with the aim of contributing once again to the informed and plural discussion on the challenges of the world of work, and more specifically with regard to collective bargaining in the strict sense and social dialogue in the broad sense, this conference is organised. Since the Oñati Declaration (2019), the Vice-Ministry of Labour and Employment of the Basque Government has been implementing various legal and political initiatives within the scope of its competences, with the aim of contributing to improving the quality of work in the ACBC. These measures are based on the conviction that the promotion of collective bargaining and broad-based dialogue open to all social agents, as well as the promotion of the participation of people in companies and social learning, are key instruments for improving the quality of work, and thus for broader social transformation in the direction indicated by the ILO.

The aim of the III Conference, which will be organised by the IISL of Oñati and the University of Deusto, in collaboration with the UPV/EHU and the ILO, is to present, discuss and take stock of the most outstanding experiences in this field promoted by the various social partners, as well as by the Basque Government, and to consider them in the light of the comparative experience in the European and Southern Mediterranean contexts. With this we also want to respond to the recent initiative of the ILO itself to publish the Report on Social Dialogue Collective bargaining for an inclusive, sustainable and resilient recovery (2022), examining, from a perspective open to all social partners, and attentive to developments in this field in our international environment, with the aim of moving forward, with the help of leading specialists in the field, in the best direction.

New perspectives on socio-legal research on labour in a changing world

As a complement to the III Conference to promote the Oñati Declaration, the Research Seminar "New perspectives of socio-legal research on labour in a changing world" will take place. It will also be held at the Bilbao campus of the University of Deusto, in the afternoon of 23 October. Aimed at postgraduate students and young researchers from the Basque research system and other universities in our environment, it is an opportunity to approach from a socio-legal perspective the study of the new realities of the world of work, its regulation and governance, as well as the new methodological approaches in this field of research, in areas such as labour law, social rights, company law, labour relations, collective bargaining and sociology of work.

The Seminar, which is expected to bring together a group of 20-25 participants, will be led by a group of researchers from the University of Deusto. After their initial interventions, they will enter into dialogue with the group of participants who will have the opportunity to explain their projects.
