Current: Course Convenor and Course Lecturer – Law and Markets (LLM Course; 70 students)

Led on the design of a new inter-disciplinary LLM course (co-taught with Dr. Javier Solana) that enhances the ability of law students to engage with economic theory. Students are introduced to the basics of Neoclassical economic theory and its applications and adjustments in Law and Economics scholarship. They are given counter-narratives on how markets operate from political economy, economic sociology, and anthropology. The second half of the course focuses on how economics and lawyers understand key concepts such as 'contract', 'firm', 'market failure', and 'perfect competition'. **Responsibilities:** In charge of designing the syllabus; delivering half of the lectures and seminars; managing the Moodle page; setting and marking assessed essays; writing and market the exam; dealing with student concerns.

Current: Course Coordinator and Course Lecturer – Law and International Development (LLM Course; 30 students)

Co-developed a new interdisciplinary and intra-legal LLM course on law and international development. Students are schooled in competing theories of international development and examine different institutional frameworks for advancing international development at the supranational level. The course utilises real-life development projects and case studies, and students engage in group work to produce a project report. The course offers students the opportunity to develop skills that are foundational for work in the development sector.
