### Free resume summary

Brief description of the scientific career, the main scientific-technical achievements obtained, the scientific-technical interests and objectives in the medium/long term of the line of research. It also includes other important aspects or peculiarities.

International Doctor Researcher and Assistant Professor Doctor of International Relations, East Asian Studies and Japan, with a research career of more than 12 years certified by ANECA with accreditation as a Professor Contracted Doctor (PCD). Obtaining a six-year period of living research.

My work has been motivated by the main objective of building bridges between Asia and Europe in general, and Spain and Japan in particular. This is in addition to my goal of promoting Spanish academia and positioning it at the centre of global discourse. Awarded the prestigious Japan Foundation Postdoctoral International Japanese Studies Fellowship for a 12-month research in Japan developing as principal investigator the project "Communication, Democracy and Policymaking in Japan: A Study on the Role of International Communication in Japanese Social Cohesion and in Government Social Support", as a visiting researcher at the Graduate School of International Relations (GSIR), at the International University of Japan (IUJ). The total funded amounts to €48,200, being the most competitive and best-funded Japanese studies fellowship in the world. The researcher has been the only one in Spain to have received the fellowship in the years 2016/17. The Japan Foundation Fellowship is the Asian equivalent of the EU Marie Curie Fellowship and the US Fulbright Scholarship. This research involved conducting a nationwide survey in Japan, with a sample size of +3500, using a quantitative methodological approach and the advanced SPSS software as an analytical tool to identify the relationship between international communication and Japanese society. The field research was conducted at Osaka University's Faculty of Law and Politics and Osaka School of International Public Policy (OSIPP).

He is part of the Japan Research Group at the University of Zaragoza, which has been awarded the Reference Research Group of the Government of Aragon, one of the main research groups in Japanese Studies in Europe. In addition, he demonstrated a consolidated capacity to participate, create and lead international research groups, such as the International Research Group at Kobe University, in Japan, and the India-EU-Japan Security Studies Network, connecting Zaragoza with the international research centres in Kobe and Delhi.



Development of a global research activity consisting of numerous international seminars and research positions in Japan, New Zealand, UK, China, USA, Belgium, India and France. This international research allowed me to publish 21 articles and book chapters in high-impact international journals and publishers indexed in SPI Q1 or SCOPUS Q3, as well as in the media, facilitating the transfer of knowledge to society.

Duties held: My research career allowed me to belong to the Japan

Research Group at the University of Zaragoza (UNIZAR), awarded as a Reference Group by the Government of Aragon. It is one of the most important in Europe in the political, legal and artistic study of Japan. In this research group, I have promoted academic cooperation between Spain and Japan, encouraging the recognition of Spanish academic discourse in East Asia. Using the research group, I have promoted numerous international conferences and articles such as the 5th International Conference on Japan and Water (2017, where I contributed a possible peaceful solution to the territorial conflict of the Senkaku Islands. Another example is the 6th International Conference celebrating 150 years of relations between Spain and Japan, where I conducted a comparative study of the communicative, social and academic dimensions between both countries. I also contributed to the European promotion of the UNIZAR Research Group, advancing its integration into the pan-European network of Japanese Studies Takumi, as well as in the Centre Européen d'Etudes Japonaises d'Alsace (CEEJA), in France. In addition, I collaborated in the dissemination of research results in three dimensions. Firstly, to society, with information activities and knowledge transfer. Secondly, to graduate and postgraduate students through classes in the Diploma of Japanese Studies and in the subjects of International Relations and Public International Law. Finally, through international conferences such as the AAS-in-Asia International Conference held in Delhi, India; or the upcoming ones already accepted such as the AAS-in-Asia to be held in Bangkok, Thailand, the Leiden University in the Netherlands and the Asian Studies Conference in Saitama, Japan. I have also helped to obtain international funding sources for the projects developed by the research group, such as funding from the Japan Foundation (2016) to carry out postdoctoral research as a member of this group, funding from Hosei University (??? ???), in Japan, for participation in the CEEJA (2017, 2018) or private funding for incorporation into the pan-European Takumi group (2018).

I research how different societies in a globalized world can protect their resources, enhance their international projection, increase their competitiveness and achieve transnational democratic solutions to global challenges using non-traditional diplomatic channels: international communication, cultural exchanges, business innovation and scientific research. The development of Cultural Diplomacy as a discipline for the promotion of regions and countries in the globalized world led me to reinforce the theoretical model and share my findings with research positions in centers and universities around the world, such as the School of Oriental and African Studies.

(SOAS) (London), Brussels School of International Studies (Brussels), Library of the European Parliament (Brussels), University of Auckland (New Zealand) and British Library (London). My research also received a competitive merit-based grant from the Government of Navarra for a total amount of 59,800 euros. Since then, I have dedicated my career to empirically finding ways to internationally promote intercultural social interactions through cultural diplomacy. Therefore, this line of research forms a perfect symbiosis with my second line of research focused on Japanese studies. This research will also allow me to continue attracting international funding for Spanish research projects.

It will also allow me to continue building bridges of cooperation between the scientific communities of Spain and Japan in particular and of Europe and East Asia in general.

Teaching research results to graduate and postgraduate students A fundamental responsibility of a researcher, in addition to conducting good research, is to disseminate and share the research and knowledge acquired.

This purpose is best served by teaching, and for me the opportunities came in the form of teaching appointments at national and international levels. I have been a lecturer in International Relations, World Politics, Global Communication, Asian Politics: China, India and Japan, Political Communication and Public International Law subjects at the University of Navarra (2011-14, 2018-19), Francisco de Vitoria University (2017-), Universitat Internacional de Catalunya (2013-15) and University of Zaragoza (2017-18). I have also been a visiting professor in Japan at Kobe University (2018-19), the International University of Japan (2016-17), the University of



Dokkyo (2019) and Osaka University (2016-17), marking a teaching career that spans over nine years. . This has also been an opportunity for me to learn and grow as a researcher and as an individual, interacting with young minds every day.

of the research, both the theory of rational choice and

alternative formulations have been studied under the theoretical framework of game theory. This scenario has found much confusion and ambiguity in the labeling and understanding of these theories, since different conceptual and methodological proposals have been wrongly considered as similar and similar proposals wrongly identified as different. The contribution of this thesis to the chaotic panorama of theories of rationality has been the proposal of a study in a comprehensive two-dimensional scheme based on two factors: the complexity of the actor in each theory (simple and complex) and the final objective of the study (incentives, actor behaviors on the one hand and the state of interactions between them, on the other). Thus, after applying this proposal for the study of choice theories, it has been concluded that rational choice theory has focused mainly on the incentives and responses of simple actors, so the main field of application has been economics. Positive political theory has focused on complex actors, largely studying the functioning of political parties and coalitions. Social choice theory has the opposite niche to rational choice when it studies the interactions between complex actors such as nations, societies and cultures.

Public choice theory has finally focused on the relationships established between simple actors such as those created in constitutional and negotiation processes. Once this proposal was applied, in a consistent, unified and integrated order, the research synthesized the most interesting elements of each formulation to build the communicative analysis model. This is composed of four modular elements according to the analyst's capacity to acquire and process information, thus offering a high adaptability of the analysis to multiple social scenarios. This model consists of four elements: first, the ordinal articulation of the complexity of the actors and the clustering strategy allows us to consider them as simple or complex according to the informative capacity of the analysis.

Secondly, the study of the multiplicity of interaction dimensions allows for harmonization in an integral scheme. Thirdly, the consideration of the communicative projection of the hierarchy of preferences allows us to study the process by which individual systems are organized into a group. Finally, the calculation of the equilibrium point reached between actors can explain the social scenarios achieved as a result of both communicative action and participation in other interaction dimensions. Thus, in its application to international communication and, more specifically, to the case study of the dispute over the Senkaku/Diaoyu Islands, this model has been able to unite, in a single interaction model, all these elements by formally analyzing them and offering an explanation of the equilibrium point reached, as well as the potential evolutions with the modifications of the factors that configure it.

Relevant results: Game Theory is a model of study of the interactions between different actors (politics, economics, etc) that analyzes the interrelation that is established among them with the final purpose of reaching the maximization in the individual benefit of each of player. In the scheme of structuration of the Cycle of Intelligence designed by Robert M. Clark (Planning, Recollection, Processing, Analysis and Diffusion), the employment of Game Theory in the communicative discourse analysis offers interesting application possibilities in its fourth phase: Analysis and Production. This perspective makes new chances for the analysts possible based on three reasons. First of all, the consolidation and diffusion of the society of information as a global social model has caused a displacement in the typology of the sources employed during the Recollection phase. This change has consisted of the progressive substitution of closed sources for open ones or OSINTs. Second, this change of paradigm has also modified the localization of the most difficult steps in the Cycle of Intelligence: before the consolidation of the information society, the Recollection phase was typically the most difficult and, therefore, the most costly in terms of economic and human resources. After this change of sociological paradigm, the hyper abundance of information has made the OSINTs more employed than the closed ones, having reduced the cost of the Recollection phase. But this has had a counterpart: this increase in the quantity of collected data has increased the complexity of the process of this information exponentially. As a result, the need to develop better filters for data selection has become a substantial factor for all the Intelligence procedures. Finally, the Game Theory model allows one to employ a theoretical model with a high degree of flexibility and adaptability for analyzing the varied roles of the different political, economic and social actors that are played in any international dimension. These potential fields of study include, but are not limited to, Public Diplomacy, formal diplomacy or any other typology of interactions between complex social players. The conclusion of this research is that the massive employment of OSINTs in this new society of information social paradigm makes necessary the use of communicative analysis to achieve a high level of accuracy in the Cycle of Intelligence. The proposed Game Theory based model offers an efficient way to achieve this objective with a minimal cost in terms of time and computing effort.

Relevant results: The application of the Game Theory as a theoretical model for the communicative analysis has provided interesting methodological tools with which it has been possible to identify, classify and study different communicative phenomena with great depth. One of these detected phenomena is the Multi-Player phenomenon, which consists of the multiplicity of roles that a single entity plays in a communicative field of interaction. This modeling of the social reality has a great interest in the Public Diplomacy because this is the field where the identities of the social, political and cultural actors are more diffused and, therefore, difficult to identify. This difficulty also extends to the study of their communicative behavior in this field. The theoretical modeling of the Multi-Player phenomenon is conducted by a basic matrix of Game Theory adapted to the communicative field. This implies the identification of the elements Player, Field of Interaction and Goal of Interaction. This structure combines the conceptual strength of the mathematical-functionalistic dimension of Game Theory with the versatility of its philosophical-political dimension. This combination leads to the creation of a tool that can be applied in a wide variety of communicative scenarios due to its adaptability. This analytical matrix can be applied to the study of the political and institutional communication as integral parts of a whole communicative ecosystem due to the fact that the entities that emit their messages develop a multiplicity of roles in the society of information. The research has concluded that it is possible to identify, analyze and quantify the different roles that a single entity develops in different dimensions. Therefore able to predict the future evolution of the field analyzed with a higher level of accuracy and understanding of the communicative phenomena. This offers to the scholars a useful tool to analyze the social and communicative environment and their links towards the political actors that participate in the domestic and international dimension.

Relevant results: The study of the role that China plays as a political actor in Asia-Pacific has been conditioned by two fundamental factors. First of all, the inner dimension of the Communist Party. Secondly, the outer dimension that implies the transformation of the country into the "industry of the world". These two factors have been analyzed from the binary perspective of the "stabilization-destabilization" of the political environment. This is a paradigm that has been revealed inexact and inefficient. It is necessary to overcome this limited paradigm and substitute the conceptual variable "stability-instability" by the variable "maintenance-rupture of the status quo" in order to analyze the role that China plays in the political context of the Asia-Pacific. This new paradigm recognizes





that not all the international stability of the political dimension is reached by the maintenance of outdated social, political and economic structures. At the same time, it points out that not all the rupture of these structures, when they are obsolete in a rapid change global environment, leads to international instability. Analyzing the role of China according to this new variable (maintenance-rupture of the status quo) offers more efficient tools to understanding the role of China in the globalized world of the early 21st century. The conclusion of this research is that the economic and diplomatic success of China is creating a powerful network of incentives for the Chinese Communist Party to maintain the current status quo of the international political environment. This is leading to the emergence of China as an atypical non-interventionist global power that tries to maintain the current international conditions to continue this intense growth process. At the same time, if this growth is not maintained, China can have incentives to modify the international status quo in order to re-configure it and to generate new conditions to achieve this growth. This analysis allows one to overcome the limited vision of China as a factor of stabilization-destabilization and substitute it for the more accurate conceptualization of China as a diplomatic player that develops a role in the maintenance-rupture of the current international status quo depending on the incentives that each option will provide. At the same time, this article discusses the idea that the Communist Party of China is transforming its communicative claim for legitimacy from an ideological basis to a pragmatically and nationalistic one. The economic success of China and the governmental promotion of a nationalistic sentiment have become two important propaganda tools for the communicative role of the CPC. This has had an important effect in the Public Diplomacy designed and projected from Beijing towards the political environment of the Asia Pacific, on a regional scale, and to the entire globalized world, in a global perspective.
